- (1) Party must have done the similar work for about Rs. 19.31 lakhs per annum in single award or having two similar works not less than about Rs. 12.07 lakhs each or three similar works not less than about Rs. 9.66 lakhs each per annum during the last preceding seven years on or before 31.12.2020. The party must be in the above service during the last 7 years and should have all mandatory license/Registration Certificates issued by Govt. to carry out such works.

The contractor will rectify the pointed out the defects within the time period given by Engineer In-charge, STC and shall remove from the site all the rejected materials immediately.
- (ix) The contractor will be fully responsible for any injury or accident to any person(s) employed by him during the execution of work or to the employees and, for any damage/loss caused to any structure or any part of the property due to the negligence/default on the part of the contractor, the Contractor would be wholly liable to make good/repair the same at his own cost and expenses.
- (x) The contractor, at his own cost, shall obtain Third Party Insurance Policy & Workmen Compensation Policy in joint name of STC Of India Ltd. and contractor, with STC's name appearing first for the appropriate value, which shall remain valid till the completion of work.

- (xv) No condition/deviation which is either additional or in modification of tender conditions shall be included in the bid submitted by the Bidder. If the offer contains any such condition or deviation from the tender conditions then the said bid shall liable to be rejected. STC's decision in this regard shall be final and binding.
- (xvi) In the event of the tender being submitted by a partnership firm, Memorandum of Association, certificate of incorporation and board resolution is necessary. In case of partnership firm registered deed of partnership is necessary.

Completion certificate will not be issued until the contractor clears the site of all malba, scaffolding, surplus materials and huts etc. and remove all dirt and dust from the site.
- (xix) The successful bidder/applicant is required to furnish 'KYC' details as per STC's format before work is awarded to him/them.

8. Other Terms and Conditions

(a) The work will be executed strictly as per specifications mentioned in the Schedule of Quantity and to the entire satisfaction of the Engineer In-charge, STC and time period of completion of entire work will be **120 days** to be reckoned from the 7th day of the date of award of work from the STC to the successful Bidder/Awardee to commence the work.

The Awardee, before commencing the work, shall prepare a detailed work programme and submit the same to STC within 7 working days from the date of award of work.

In case, the successful party/bidder/awardee does not commence the work by stipulated date in terms of Award Letter, and/or party/awardee backs out of the contract midstream or does not provide service to the full satisfaction of STC, STC shall without prejudice to any other right/remedy, be at liberty to forfeit the said EMD and Performance Bank Guarantee, absolutely in addition to recovery of other damages/losses caused to STC on this account and the party shall also be Black Listed for participation in all subsequent tenders and informed to all PSU's and other authorities concerned.

(b) **SECURITY DEPOSIT**

- (i) The security deposit shall be refunded without interest by STC after expiry of Defect Liability Period i.e. **12 month** from the date of completion of the work and after due certification by Engineer In-charge, STC that no defects have been noticed in the work.
- (c) If the Contractor/Awardee desires an **extension of time** of completion of the work on the grounds of unavoidable hindrance in its execution or any other ground, he shall forthwith give written notice of cause of delay to the Engineer-In-Charge, STC. GM/CGM, STC shall authorize such extension of time as may in his opinion be necessary and proper. No application for extension of time shall be considered by STC under this clause unless it is made by the contractor before scheduled date of completion of work.
- (d) If the contractor/Awardee (including member of MSME/NSIC) fails to complete the work in time including approved extended time period of completion, penalty/liquidated damages for non-completion of the work @ 1% of the contract value for each day of delay including holidays till completion of work, subject to maximum of 10% of the contract value of work shall be recovered. The decision of STC in this regard, shall be final and binding on the contractor.
- (e) STC may at its discretion, change or alter any specifications or design during the course of execution of the work and the contractor shall have no objection to the same.
- (f) The Contractor/Awardee (including member of MSME/NSIC) shall execute an agreement on non-judicial stamp paper of Rs. 100/- with- in one week's time from the date of issue of award work as per approved Performa. The cost of stamp paper shall be borne by the party. This notice of tender shall form a part of the agreement..
- (h) The contractor/Awardee shall submit the running/final bills in duplicate, giving complete description of items of work done strictly as per Schedule of Quantity.
- (i) The rates quoted shall be inclusive of all the taxes viz, **GST**, **etc.**, for all tools & plants and everything necessary for proper execution of work to the entire satisfaction of STC and no escalation due to increase in price of materials/labour shall be made during the agreement including extended period.
