**5. Under ANNEXURE VI i.e. TERMS OF SHIPMENT ON C&FFO BASIS, clause 19 stands amended as follows;**

The cargo to be discharged at an average rate of 2500 MTs for Mumbai and 3000 MT for Kolkata Port Per Weather Working Day (PWWD SAT NOON SHEXEIU) and of 24 consecutive hours based on minimum number of four workable hatches or prorate if less. Each hatch must have one gear/crane. Sundays and Holidays excluded, even if used and weekend to be counted from SAT 12 00 HRS to MON 08 00 HRS i.e time not to count as lay time used. If detained longer, receiver to pay demurrage at the rate of **USD 12,500/-** per weather working day (**USD 5,000/-** per weather working day in case of desi chick peas) and on prorata for any part of the day. Dispatch money, if any, shall be paid by the Seller to Receiver at half the demurrage rate for all the time saved. Lay time at discharge port shall commence 24 hours after the notice of readiness has been received in writing by Fax or cable by the receiver on all working days from Monday to Friday between 1000 hours to 1700 hours, provided Fax message was not garbled and mutilated.

ALL OTHER TERMS & CONDITIONS OF THE SUBJECT TENDER REMAIN OTHERWISE UNCHANGED.
