TERMS & CONDITIONS

1. The tenderer/bidder shall deposit an EMD amounting to Rs. 50,000/- in the shape of DD/Banker's Cheque in the name of "STC OF INDIA LTD", payable at NEW DELHI.
2. The tenderer/bidder who submits the tender by not accompanying the cost of tender (in case tender is downloaded from website) and EMD will be summarily rejected.
3. The successful tenderer/bidder shall deposit a Security amount equal to 5% of total cost of material i.e. stainless steel dash fasteners ordered for the due fulfillment of the contract in the form of Pay Order/DD in the name of "STC of India Ltd.", payable at "New Delhi", and no interest will be paid on Security Deposit/EMD. However, the EMD amount deposited earlier shall be adjusted against the security amount. The security amount will be returned back to the party within 30 days reckoned from the final receipt of quantity of material.
4. The EMD of the un-successful tenderer/bidder shall be refunded within thirty (30) days from the date of placement of supply order.
5. Payment will be made only after receipt of material in good condition along with Test Certificate as per requirement.
6. Payment against the defective material, if any, shall be with-held till its replacement with new one but not beyond 10 days is made by the party.
7. The delivery period shall be one month to be reckoned from the date of placement of order. In case supply is not made within the stipulated period as per tender condition, the STC may cancel the order and procure the same from any other source at the risk & cost of tenderer/bidder and EMD stands forfeited.
8. The delivery of the stainless steel dash fasteners is to be made at Jawahar Vyapar Bhawan, New Delhi.
9. The price offered shall be inclusive of taxes, cartage etc.
10. Price offered should be firm for a period minimum of 90 days. The offer once made cannot be withdrawn or modified under any circumstances. Withdrawal or modification of the offer once made will result forfeiture of EMD remitted.
