## **ANNEXURE II**

Terms and conditioners for disposal of old (scrap) items by tender:

- 1 The party should give quotations for the scrap items for Lot No.1 and Lot No. 2 separately. The quotation should be inclusive of applicable taxes.
- 2 An EMD equivalent to 10% of the rate quoted by the party; by Demand Draft/Banker's Cheque favouring the State Trading Corporation of India Limited payable at Chennai should accompany the tender. Quotations without the EMD will be summarily rejected.
- 3 As the items listed in Annexure I are offered on "As is where is" basis and no claim regarding the quality etc. will be entertained by STC on a later date.
- 4 The successful tenderer should deposit the balance bid amount(excluding the EMD) within 3 days from the date of award of the tender.
- 5 A free time of 1 week from the date of issue of Delivery Order will be allowed to lift the materials from our office premises. Delivery of the items from our premises, loading, unloading and transportation of the items will be to the account of the bidder.
- 6 Any delay in lifting the items beyond 1 week will attract carrying cost of Rs. 50/- per day.
- 7 Maximum of 1 week time beyond free time will be allowed to lift the material after payment of carrying cost.
- 8 In case the H1 party did not lift the material after 2 weeks time as above, for reasons whatsoever, the total amount deposited by the party will be withheld and the lot will be offered to the H2 party. The difference between the H1 and H2 will be adjusted in the amount deposited by the H1 party and balance amount, if any, only will be refunded to the H1 party after due completion of the lifting process by the H2 party.
