STC has been dealing in import and export of diverse range of items through its network of offices located in major cities and ports all over India.

STC intends to appoint reputed independent third party surveyor & valuer to conduct thorough quantity and quality survey of stocks lying at Balgopalpur and Kaliapani mines, Jajpur (Odisha). STC hereby invites applications on Company's letter head from interested Surveyors & Valuers on following terms and conditions:-

- 1. Scope of Work: The scope of work shall include determination of quantity, quality showing all major specifications, current market value of-LAM Coke and Chrome Ore Lumps lying at Balgopalpur (Odisha) and Chrome Ore lying at Kaliapani mines Jajpur (Odisha).

- 2. Qualification: The applicant should be :
 - **a.** Having laboratories/ offices etc. presence in major cities in India.
 - **b.** Having own inspection and quality analysis laboratories. All the laboratories must be fully accredited (ISO standards) by concerned Accreditation associations/bodies.
 - **c.** The applicant should not have been blacklisted / banned for participation in any Empanelment/Tender intended by Government or by any Government Undertaking in India for inspection valuation or for any other work. The applicant shall have to submit an undertaking on non-judicial stamp paper of Rs 100 to this effect at the time of application.

Applicants have to submit documentary evidence in support of all above. Refer: Annexure-B.

- 3. Submission of Bid: Bids are to be uploaded on www.eprocure.gov.in/eprocure/app as per two parts bid process i.e. Part I (Technical Bid) (Refer: Annexure-B and Annexure-D) and Part II (Commercial/Price Bid) (Refer: Annexure-C) on applicant's letter-head. Documents to be signed by authorized representative of applicant.
- 4. Bid Security: Applicants shall submit Bid money of INR 25,000/- (Rupees Twenty five thousand only) in the form of Demand Draft favouring "The State Trading Corporation of India Ltd." payable at Kolkata. The Bid money shall be converted into a Performance Security amount (EMD) on award of the contract and shall remain with STC initially for 12 months (then depending upon renewal of the contract) from the date of commencement of the contract. Original Demand Draft physically by post, must reach STC before closure of the tender. No interest will be paid on EMD amount. - **5. Inspection Charges:** Applicants to quote their lowest rates on Lump sum basis for carrying out quantity, quality analysis and determination of current market value of said stocks for each completed survey/valuation work at both locations. Refer: Annexure-C.

As per the policy of the Corporation, the survey and valuation work of the stock to be undertaken every 45 days. However, STC does not guarantee number of works related to survey and valuation. Hence, prospective bidder is to submit quotes per completed survey/valuation work at both locations.

- **6. Term of Appointment:** Appointment would be initially for one year and extendable at the discretion of STC subject to satisfactory performance and for the specific work allotment as per the scope of work. Award of this tender does not implies empanelment with STC.
- 7. Payment: Payment of inspection charges (details mentioned at point no.5 above) will be made by STC after presentation of requisite documents viz. Invoices in triplicate along with originals of Certificate of Quality, Certificate of Quantity and Certificate of value, Refer: Annexure-A.

8. General / Other Terms and Conditions:

- a. Technical bid and commercial/price bid must be uploaded separately by the applicant on www.eprocure.gov.in/eprocure/app. No bids shall be accepted in hard copy or in any other form.
