1.	Prices:	Please quote your most competitive unit and total prices on CIP New Delhi (by air) basis for the main item as well for recommended essential accessories and spare parts.  In addition to above, please also quote your prices on CIP Bhopal (by air) basis for requirement of Madhya Pradesh Police and on CIP Bangalore (by air) basis for requirement of Karnataka Police. 2.	Validity:	Your offer should be valid for acceptance for a period of six months from the date of your quotation.
3.	Delivery Schedule:	Please quote your firm CIP delivery schedule from the date of placement of order and establishment of Letter of Credit, whichever is later.
4.	Payment terms:	STC operates on CAD / Letter of Credit basis. In case you desire the payment against Letter of Credit, please note that we shall open L/C for 100% value of the order on receipt of your proforma invoice giving details of your bankers. The mode of payment under the L/C would be 90% payment will be released against dispatch document and balance 10% of the payment will be released against acceptance by the end-user Department. 9. Liquidated damages:	In case of delay in supplies beyond the quoted delivery period, liquidated damages to the extent of 0.5% of the cost of the delayed supplies per week is applicable, subject to a maximum of 10%. Beyond this period, we reserve the right to either extend further or to cancel the contract.

13.	Performance Guarantee:	Upon award of the Tender/Order, you would be required to submit a Performance Guarantee for 10% value of the order for due performance of the Contract, valid up to the warranty period of the equipment. The format of Performance Guarantee to be submitted through a local

14.	<b>Specifications:</b>	You have to provide detailed specifications of the items being quoted by you in your offer.
15.	Arbitration:	Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, operation or effect of the contract or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration, New Delhi and the award made in pursuance thereof shall be binding on the parties.

18.	Proprietary Article Certificate	Please submit original Proprietary Article Certificate on your letterhead confirming that you are the actual manufacturer of the quoted items. Please also confirm that you are the only company that is authorised to supply the Original Equipment Manufactured and its spares into the territory of India.
19.	Force Majeure	If at any time during the existence of the contract either party is unable to perform in whole or in part any obligation

under this contract because of war, hostility, civil commotion, sabotage, terrorist attack, quarantine restrictions, acts of God and acts of Government (including but not restricted to prohibition of exports or imports) fires, floods, explosions, epidemics, strikes, embargoes then the date of fulfillment of engagement shall be postponed during the time when such circumstances are operative.

Any waiver /extension of time in respect of the delivery of any installment or part of the goods occasioned due to reason mentioned above shall not be deemed to be waiver/extension of time in respect of the remaining deliveries.

If operation of such circumstances exceed three months, each party shall have the right to refuse further performance of the contract in which case neither party shall have the right to claim eventual damages.

The party which is unable to fulfill its engagements under the present contract must within 15 (fifteen) days of occurrence of any of the causes mentioned in this clause inform the other party of the existence or termination of the circumstances preventing performance of the contract. Certificate issued by the Chamber of Commerce in the country of Seller or the Buyer shall be sufficient proof of existence of the above circumstances and their duration. Non-availability of raw material will not be an excuse to the Seller for not performing their obligation under the contract.
