The State Trading Corporation of India Ltd. (STC) invites offers for appointment of panel of suppliers for purchase of "PP BAGS" for bagging pulses as per details and other Terms & Conditions given below:

**1. ITEM :** P. P. Bags ( WHITE COLOUR )

**2. QUALITY / SPECIFICATIONS :** Size - 24" X 36" Weight - 100 gms. (Minimum)

The bags should be made of HO-30SG

The bags should have hamming cut.

**3. QUANTITY :**

Total Quantity to be offered - 10,000 (Ten thousand) ( +/- 5% ) bags.

The above quantity is tentative and STC reserves the right to increase or decrease the quantity tendered.

**4. PRICE :**

Price to be quoted in Annexure-1.

**5. VALIDITY :**

Offers must remain valid till **15.07.2012**

**6. EARNEST MONEY DEPOSIT (EMD) :**

a) Offer shall be accompanied by an **EMD of Rs. 10,000/-** in the form of Demand Draft/Pay Order/Banker's Cheque/RTGS in favour of The State Trading Corporation of India Ltd., payable at Mumbai.

Offers should be submitted as per price bid format provided at **Annexure-I**. The Tender Bids will be opened on 05.07.2012 at **15:15 hours**. Tendering parties' authorised representative may attend the opening of the Tender Bids.

#### **The following conditions must strictly be complied with:**

- a) Each page of tender document must be signed by the Bidder as a token of their acceptance of tender terms & condition.
- b) Offer(s) incomplete or deficient, received late and/or not accompanied by valid EMD shall not be accepted and outrightly rejected.
- c) STC reserve the right to accept or reject any or all bids wholly or partially or counter the bid(s) without assigning any reasons thereof.
- d) If two or more bidders quote the same lowest (L-1) rates, STC reserves the right to award the tender in split form.

#### **8. SAMPLES :**

The tenderer must bring TWO nos. of PP Bag sample as per specification given above and the same should be given at the time of opening of the bids.

#### **9. PLACE OF DELIVERY : NAVI MUMBAI / URAN, JNPT**

**All the incidental expenses related to delivery will be to the account of the supplier.**

**The weight and quality as per observation of our surveyors will be final.**

**10. DELIVERY SCHEDULE : IMMEDIATE. i.e. SECOND WEEK OF JULY 2012**

Delivery should be strictly as per the approved samples and necessary checking/observation of our surveyors and as per the schedule given by STC.

STC reserves the right to forfeit the EMD or recover cost from successful bidder in case the successful bidder -

- a) Fails to supply quantity of bags within the specified period.
- b) Fails to supply the quality of bags as per tender requirement.
- c) Commits any breach of Contract or fails to fulfill any term(s) or conditions(s) of the Contract.

**11. DOCUMENTS CONSTITUTING CONTRACT:**

The Invitation of Bids, the terms and conditions of Tender, Bid of the Seller and Letter of Acceptance issued by STC along with any amendment shall constitute the Contract between the Buyer and the Seller.

**12. FORCE MAJEURE:**

Should any of the force majeure circumstances, namely act of God, natural calamity, fire, Government of India Policy, restrictions, strikes or lock-outs by workmen, war, military operations of any nature and blockades preventing the Seller/Buyer from wholly or partially carrying out his contractual obligations, the period stipulated for the performance of the Contract shall be extended for as long as these circumstances prevail, provided that, in the event of these circumstances continuing for more than three months, either party shall have the right to refuse to fulfill its contractual obligations without title to indemnification of any losses it may thereby sustain. The party unable to carry out its contractual obligations shall immediately advise the other party of the commencement and the termination of the circumstances preventing the performance of the contract. A certificate issued by the respective Chamber of Commerce shall be sufficient proof of the existence and duration of such circumstances.

**13. ARBITRATION:**

Any dispute or differences that may arise between the parties' out-of or relating to the construction meaning, operation, effect or performance of this contract or breach thereof shall be settled amicably between the two contracting parties. If the dispute cannot be resolved then the matter shall be settled by arbitration as per rules of The Indian Council of Arbitration in accordance with the Indian Arbitration Act, 1996 at Mumbai, India only. The arbitrator(s) shall be retired judge of High Court or Supreme Court from the panel of Arbitrators of Indian Council of Arbitration. The third arbitrator if appointed shall be senior to nominated arbitrator(s).
