- 2. The Surveyors should have handled <u>containerized cargo</u> of atleast 10,000 MTs of pulses import in each year in the past two years i.e. F.Y. 2010-11 and 2011-2012 at JNPT/ NHAVA SHEVA. A documentary proof of having handled the said quantity of cargo should be furnished with full details like name of the vessel, commodity, tonnage, party-wise break-up of cargo handled may be submitted.
- 3. The Surveyors should have handled **bulk cargo** of atleast 25,000 MTs of pulses import **in each year** in the past two years i.e. F.Y. 2010-11 and 2011-2012 at Mumbai.
