5. Rates to be quoted on **PER METRIC TON basis for bulk cargo/break bulk bagged cargo and CONTAINER basis for containerized loose cargo/bagged cargo** inclusive of all Taxes / Cess / Levies etc. separately for each type of operation only in the formats provided as Annexures.
6. The appointment is for a period of ONE YEAR and the same shall be extended for a further period of one year on same terms and conditions at STC's option. Thus, the rates quoted should be valid for extended period as well.
