Sub: Revision of income limit for parents for the coverage of STC Employees' Medical Benefit Scheme.

In partial modification of existing STC Employees' Medical Scheme, the Competent Authority has decided to amend the following clauses as under:

Clause No	Existing provision	Amended Provision
1.3 Explanation (ii)	Parents will be regarded as wholly/mainly dependent upon an employee only if they normally reside with the employee concerned or with the rest of his family members at a place other than his duty station for whatever reasons and if their total monthly income from all sources does not exceed Rs.3000/- per month.	Parents will be regarded as wholly/mainly dependent upon an employee only if they normally reside with the employee concerned or with the rest of his family members at a place other than his duty station for whatever reasons and if their total monthly income from all sources does not exceed Rs.9000/- per month
1.3 Explanation (iii)	The amount of pension being drawn by the parents of the employees will not be taken into account for determining the income ceiling.	including the amount of dearness relief on basic pension of Rs. 9000/-.


2. Every employee of the Corporation is required to submit Dependency Declaration Certificate for the purpose of eligibility to the benefits under STC Employees Medical Benefit Scheme on beginning of every calendar year.

3. It is requested to submit Dependency Declaration Certificate as per enclosed format at Annexure-I by 31.08.2021. Further, any addition/deletion/alteration should be immediately intimated to the office for completion/updation of declaration form.



4. The above amendment in STC Employees' Medical Scheme shall come into force from the date of issue of Circular in this regard.

b) For reckoning the income of the parents. The Pension originally sanctioned should be taken into account for determining the entitlement and coverage and not the pension after commutation, subject to other conditions being fulfilled after the CS(MA) rules.

iv) In case any of the above mentioned member(s) is/are getting pension from the employer, a certificate to this effect may be enclosed.
