Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Company has received Notices from BSE Limited (BSE) and National Stock Exchange of India Limited (NSE) vide their respective emails dated 17.03.2025 regarding imposition of fines for non-compliance of provisions of Regulation 17(1), 18(1), 19, 20 and 21(2) of SEBI (LODR) Regulations, 2015 for not having requisite number of Independent Directors on the Board of STC for the quarter ended on 31<sup>st</sup> December, 2024, as per the details indicated below:
