2. The employees who are retained at Mumbai, Ahmedabad, & Kolkata will continue to operate at the existing location, till the time premises are not handed over/ transferred to the Lender Banks under OTS. Thereafter, they will operate from their residence/ place of stay to coordinate pending trade recovery, taxation and other legal matters, cases filed by/ against STC and other matters, if any.

3. For Mumbai- Shri Ashwani Kumar Verma, GM, for Ahmedabad- Shri R J Rudakia, Manager and for Kolkata- Shri Rohit Kumar, Manager will ensure proper handing over/ taking over of charge from the employees who are being relieved from the respective Branches in compliance with Circular No. IR/03/2019 dated 18.01.2019.

4. Since Shri Ashwani Kumar Verma, GM has sought VRS, the Competent Authority has viewed that his relieving will be considered only after certain administrative matters are handled towards finality by him. The list of tasks to be completed will be issued separately by Branch Director.

5. It is once again reiterated that important records required for contesting Court Cases/ Trade Recovery Matters/ Taxation/ Statutory compliances etc. need to be digitized under time bound manner under the supervision of Shri Ashwani Kumar Verma, GM (for Mumbai), Shri R J Rudakia, Manager (for Ahmedabad) and Shri Rohit Kumar, Manager (Kolkata Branch). Since every square feet of office space has a cost therefore, the file/records, movable/immovable assets not required at the Branch must be shredded/ disposed off urgently for smooth closure of Branch.

6. Those availing official accommodation would vacate the premises and handover the possession to authorised representative of STC available at the above places/locations so that premises are handed-over/transferred to lender banks under OTS.


7. Due to precarious financial conditions of the Corporation, transfer benefits will be payable except the amount of transfer grant which will not be payable. Further, the transferee Manager/ Staff has to make his/ her own

arrangement at new place of posting i.e. Agra and claim HRA as per rules of the Corporation.

8. The Competent Authority has directed that the officers retained at these Branches shall be responsible for attending all recovery matters/ trade matters/ tax matters/ property matters and contest rigorously the Court cases filed by STC and against STC. Their continuance at present location/ relieving from the Organization will be reviewed on weekly basis by Branch Director. Further, the officers retained at Branches shall observe complete financial austerity and shall complete the task with dedication and devotion to the duty.

9. Those officers from the above who have applied VRS/ applying for VRS, in such cases, the transfer orders will be reviewed to enable the individual to avail VRS benefits and get relieved avoiding shifting to new place of posting.
